Halifax County Harvest Days 4-H Pet Parade Rules and Regulations Sunday, October 8, 2006—2 PM

Date: October 8, 2006
Registration: Noon-1:45 PM
Show Time: 2:00 PM
Place: Halifax County 4-H Horse/Livestock Complex

The Pet Parade is an amateur show, designed to give youth under 19 years of age the opportunity to display and show their pets.

RULES

1. Classes are open to youth ages 5-18 years of age by January 1, 2006.
2. Pets include goat kids, lambs, cats, dogs, rabbits, caged birds, fish, etc. No large animals please!
3. Pet **MUST** remain on a leash or in a cage and under control at all times.
4. Each youth must be able to handle their animal in the show ring.
No adults are allowed to lead animals in the ring and unruly animals that may endanger other exhibitors will be asked to leave the ring.
5. Exhibitors are responsible for cleaning up after their pets.
6. Participants are encouraged to pre-register.

Entries include social security number and a \$2.00 entry fee per exhibitor.

Entry forms must be completely filled out.

Entries will be accepted until 1:45 PM on October 8th.

7. All exhibitors must be checked-in on October 8, 2006, between Noon and 1:45 PM at the Halifax County 4-H Horse/Livestock Complex on Hwy 903.
8. Animals must be in good condition and free of disease. Any animal appearing unhealthy will be barred from show and show grounds.
9. All decisions made by the judge will be final.
10. All participants will be awarded ribbons.
Premiums will be mailed following the completion of the show.
